Engagements with Departement of Home Affairs

Italcham is a proud member of the EU CHamber. Within this context was given the opportunity to engage and discuss the important issues related to immigration, visas, and skills with the South African Department of Home Affairs. It has been understood that the manner in which these matters are managed can have a positive impact on investment as well as having positive knock-on effects in terms of job creation and transfer of skills and technology. The opposite can also be true. The EU remains the largest investor in South Africa. The European Chamber of Commerce and industry in South Africa is committed to ensuring that any issues that can form potential barriers to driving economic growth are thoroughly engaged.

At the end of 2021, The EU Chamber surveyed European firms in South Africa about the proposed new critical skills list. Respondents stressed the need to ensure that immigration processes remain agile, respond to new technologies and requirements as well as not undermine investment prospects by unnecessarily driving up



costs. It was appreciated that a number of changes were made to the new list of critical skills following engagement with stakeholders on the draft that was published for comment in 2021.

The EU Chamber welcomes the inclusion of some upper and middle management positions. Company knowledge is both critical to the investment and set-up of companies, and a long-term connection with head

office and international competencies. The inclusion of a range of engineering skills in the list was also important for many of our members.

The EU Chamber must note, it was disappointing that the foreign language speaking skills were limited to call center roles. This is a limitation for companies looking to set up headquarters in South Africa and seeking to invest in Sub- Saharan Africa. Specific language skills are required and have the ability to attract large investments for Africa, centered in South Africa.



The procedural requirements for professionals and business people seeking to enter South Africa can put new investments and the expansion of existing operations at risk. This risk has been highlighted by the inefficient and lengthy process-times of visas which are an additional barrier to investment as they limit the opportunities for

companies to capitalise on and result in project delays and running over budget. There are considerable delays being reported by our members in some EU countries, including Belgium and France. In other cases, such as Croatia and Bulgaria, there appears to be a lack of urgency for providing assistance to business people who require short-term visas to come to South Africa for meetings and engagements with partners.

The EU Chamber has two additional points for future consideration. First, the EU Chamber would like to make a proposal that a specific visa linked to investment be introduced to aid in attracting new investment initiatives and

to bring in particular company skills and upper-management to launch company activities. The expansion of existing firms and new firms investing will inevitably increase economic activity and therefore create jobs locally.

Second, the length of time it has taken to revise the list of critical skills since 2014 does bode well for a flexible approach. This is increasingly important as we deal with rebuilding the economy following the unrivaled effects of COVID-19. Given increased digitalisation and internationalisation, a non-flexible list is not conducive to an evolving economy.

We propose having an extended list of basic critical skills in order to allow for greater flexibility that will account for the evolving needs of the local and international economy. This can be subject to the restriction on an investment basis to ensure the accountability of companies and governments alike.
